

BAYOU PRODUCTIONS LLC - WAIVER AND RELEASE OF LIABILITY: READ CAREFULLY BEFORE SUBMITTING ENTRY

By submitting an entry form to participate in any barrel racing event(s) produced, managed, or sponsored by Bayou Productions LLC ("Bayou Productions"), I am freely and voluntarily agreeing to the following terms and conditions:

Assumption of Risk: I understand and acknowledge that the risks of injury, illness (including but not limited to COVID-19), and accidents from equine activities are significant. These risks include, but are not limited to, permanent paralysis, disability, and death. I recognize that while rules, equipment, and personal discipline may reduce these risks, the risks of serious injury or illness still exist.

I am aware of the inherent risks of equine activities, including but not limited to:

- The propensity of a horse or other animal to behave in ways that may cause injury, harm, or death;
- The unpredictability of a horse's reaction to sounds, sudden movements, unfamiliar objects, persons, or animals;
- Collisions with other animals, objects, or structures.

I am not relying on Bayou Productions to list all possible inherent risks or hazards.

Waiver and Release: I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF BAYOU PRODUCTIONS or others, and I assume full responsibility for my participation. I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Bayou Productions LLC, its owners, officers, officials, agents, employees, volunteers, event sponsors, property owners, and other participants ("RELEASEES") from any and all claims, injuries, liabilities, damages, losses, illness, disability, death, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, that occur as a result of my participation in Bayou Productions events.

Terms of Participation: I agree to comply with all event rules, regulations, and customary terms of participation. I understand that additional terms and conditions may apply depending on the event location and may be made available upon request.

I consent to the submission of this agreement through my entry and acknowledge that submitting an event entry serves as my binding acceptance of this waiver and release.

I also consent to Bayou Productions LLC capturing, using, and publishing photographs, videotapes, and/or film in which I may appear during Bayou Productions events. I grant Bayou Productions a non-exclusive, worldwide, sublicensable right to use my name, voice, likeness, and biographical material for promotional and marketing purposes in any media, existing or future.

Governing Law: This agreement shall be governed by the laws of the State of Louisiana. Any legal disputes shall be brought in a court of proper jurisdiction located in Louisiana. If I breach this agreement and file a lawsuit, I agree to pay all attorney's fees, court costs, and related expenses incurred by Bayou Productions LLC in defending against such claims.

FOR PARTICIPANTS UNDER AGE 18: I, as parent/guardian with legal responsibility for the minor participant, have explained the risks and terms of this waiver to my child/ward. I consent and agree to their participation and, for myself, my spouse, and my child/ward, release and agree to indemnify and hold harmless the RELEASEES from any and all liabilities arising from their participation.
